### PLEASE READ THE INSTRUCTIONS CAREFULLY BEFORE FILLING THE APPLICATION FORM

1. Minimum eligibility of the candidate for the admission, He / She Should be graduate with 50% of the passing mark (SC\ST candidate 45%).
2. The last date of receipt of applications will be announced by The Director of MVD educational & Law College.
3. Incomplete application forms without attested copies of certificates will not be considered.
4. A candidate who furnishes false information or suppress materials will be dismissed and his / her fees will be forfeited.
5. The candidate will have to produce the original certificates and statement of marks at the time of admission in College.
6. The candidate whose results are yet to be declared should produce statement of marks at the time of declaration of his / her results. Unless this is done the student will not be eligible to enroll under the college rules. As such his / her admission will stand cancelled. Therefore please ensure to submit your statement of marks.
7. Those candidates who have passed a qualifying degree other than from Dr .A. P.J. Abdul Kalam Technical University, Lucknow should furnish migration certificate within one month of seeking admission.
8. Student must submit migration certificate last attended University.
9. The admission being granted is purely provisional and is subject to the total compliance with the eligibility criteria and the submission of all the certificate / Documents and is also subject to confirmation by the college authority.
10. Registration form and Deposition of Minimum Registration Fee (Rs.15000/-) is Compulsory.
11. After Registration and Deposition of Registration fee your seat will be deemed as confirmed.
12. Minimum Tuition fee for the Management Quota will be Rs. 65,500/- per year.
